

OFFICIAL RULES AND REGULATIONS

- 1. ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR TO WIN.** “The Inner Circle Sweepstakes” (“Sweepstakes”) is open to all legal residents of the 50 United States and the District of Columbia, age 18 years or older who have Internet access as of **January 1, 2017** and who have been selected by Turner Entertainment Networks, Inc. Sponsor is not responsible for providing any Internet access or use.

HOW TO ENTER:** There will be four Sweepstakes periods throughout the year: (1) January 1, 2017-March 31, 2017; (2) April 1, 2016-June 30, 2017; (3) July 1, 2016-September 30, 2017; and (4) October 1, 2016-December 31, 2017 (each an “Entry Period”). From 12:00:00a.m. Eastern Time (“ET”) through 11:59:59p.m. ET on each Entry Period, Sponsor will conduct quarterly national Sweepstakes encouraging participants to enter for a chance to win a prize. These Official Terms shall apply to each Sweepstakes conducted throughout the year. To enter a Sweepstakes, during an Entry Period, participants must complete a survey, participate in an online discussion, or enter an online registration form at www.tvinnercircle.com. To be eligible for a prize all entries must be received no later than 11:59:59 p.m. ET on the final night of a given Entry Period. All entries must be submitted in the name of an individual person and a prize can only be awarded to the person whose name is on a winning entry. Entries generated by script, macro or other automated means will be void. The Sweepstakes Entities are not responsible for misdirected, incomplete, lost, late, illegible, undelivered, inaccurate or delayed entries, or for technical, hardware, or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmissions or other errors or problems that may limit or affect a person’s ability to participate in the Sweepstakes, whether human, mechanical, typographical, printing, electronic, network or otherwise, relating to or in connection with the Sweepstakes, including, without limitation, errors that may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prizes or in any Sweepstakes-related materials. In the event of sabotage, acts of God, terrorism or threats thereof, computer virus or other events or causes beyond Sponsor’s control, that corrupt the integrity, administration, security or proper operation of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to modify, cancel or suspend the Sweepstakes. In the event of cancellation, Sponsor reserves the right, in its sole discretion, to award prizes from among all eligible, non-suspect entries received prior to the event requiring

such cancellation. False or deceptive entries or acts will render the entrant ineligible. All entries become the property of Sponsor and will not be acknowledged or returned. Limit one (1) entry per person or e-mail address per twenty-four (24) hour period. No entrant may win more than one (1) prize during a given Entry Period. Sponsor's computer shall be the official timekeeper for all matters related to this Sweepstakes.

3. **HOW TO WIN:** One 1st prize winner, one 2nd prize winner, and one 3rd prize winner (collectively, the “Winners”) will be randomly selected on or about **each approximate draw date** by a representative of Sponsor, from among all eligible entries received during a single Entry Period. For the sake of clarity, entries do not roll over into following Entry Periods. The decisions of Sponsor will be final and binding in all matters. The odds of winning will depend on the total number of eligible entries received during an Entry Period. Potential winners will be confirmed by email and must meet all eligibility requirements including the timely execution and return of all necessary releases and documents (if any) required by Sponsor. The Administrator will notify each selected entrant by email within 15 business days of the draw date.

4. **PRIZES:** 1st prize winner will receive one (1) One Hundred Dollar (\$100.00) prize, 2nd prize winner will receive one (1) Fifty Dollar (\$50.00) prize, and 3rd prize winner will receive one (1) Twenty-Five Dollar (\$25.00) prize. TOTAL AMV OF ALL PRIZES (3 PRIZES): One Hundred Seventy-Five Dollars (\$175.00). No substitution or transfer of prizes are permitted by the Winners.
